RECORD RETENTION

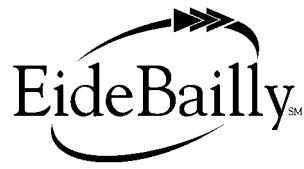
Our policy is to dispose of our copies of tax returns and workpapers, and other tax information that is more than eight years old.

We suggest that you keep your tax information and supporting documents for a minimum of eight years. We also recommend that you keep all records that pertain to a carryover amount, such as net operating loss carryovers and charitable contribution carryovers as well as capital loss carryovers, until eight years after the carryover has been consumed.

Also, we suggest that you maintain, indefinitely, copies of income tax returns, records supporting your tax basis in your personal, investment, and business assets, and documentation pertaining to gifts that you make. Your copies of the returns are enclosed for your files. We suggest that you retain these copies indefinitely.

**ADDITIONAL TAX RETURN REQUESTS FOR PARTNERSHIPS,
S CORPORATIONS, TRUSTS AND ESTATES**

In compliance with tax law [Section 6103(3) (10)], if additional copies of a tax return are requested, the requestor must complete a release form before Eide Bailly LLP can fulfill the request (including returns not listed above). In addition, the law states that the duplicate copy shall only include the requestor's personal information. Personal information (including supporting schedules, attachments or lists that include taxpayer identity information) for other partners, shareholders or beneficiaries of the taxpayer entity will be excluded from the duplicate copy. Colorado also requires charitable organizations to file a financial report annually. This report must be filed electronically on or before the 15th day of the fifth calendar month after the close of each fiscal year in which the charitable organization solicited in this state. A

failure to comply with the provisions of the Colorado Charitable Solicitations Act will result in remedies or penalties, or both. In addition to any other applicable penalty, the Secretary of State may deny, suspend, or revoke the registration of any charitable organization that makes a false statement or omits material information in any registration. The filing of the registration and financial report is a legal matter and as such is not within the scope of Eide Bailly's accounting and tax practice. Eide Bailly LLP cannot, and will not, be responsible for making sure that you have fully complied with Colorado's or other jurisdictions' legal filing requirements. In the past we may have completed one or more of these forms for you in the process of preparing your income tax returns. We have not completed any of these filings for you this year. 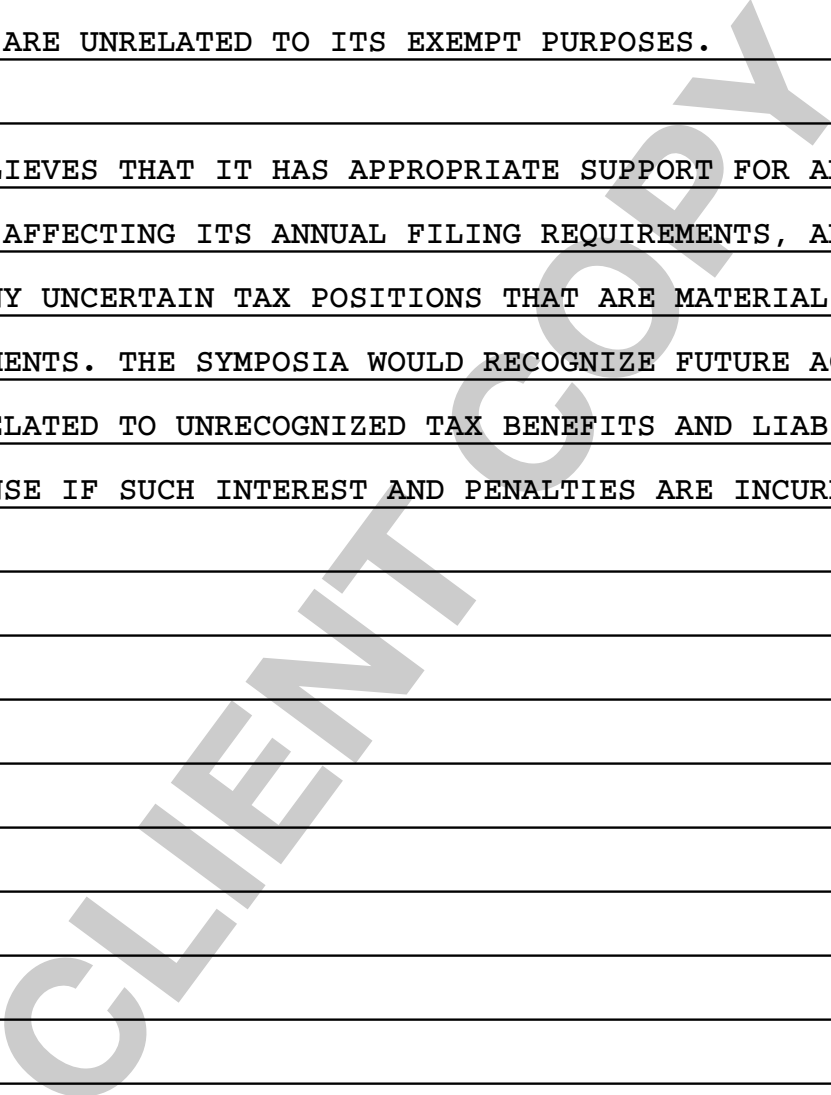

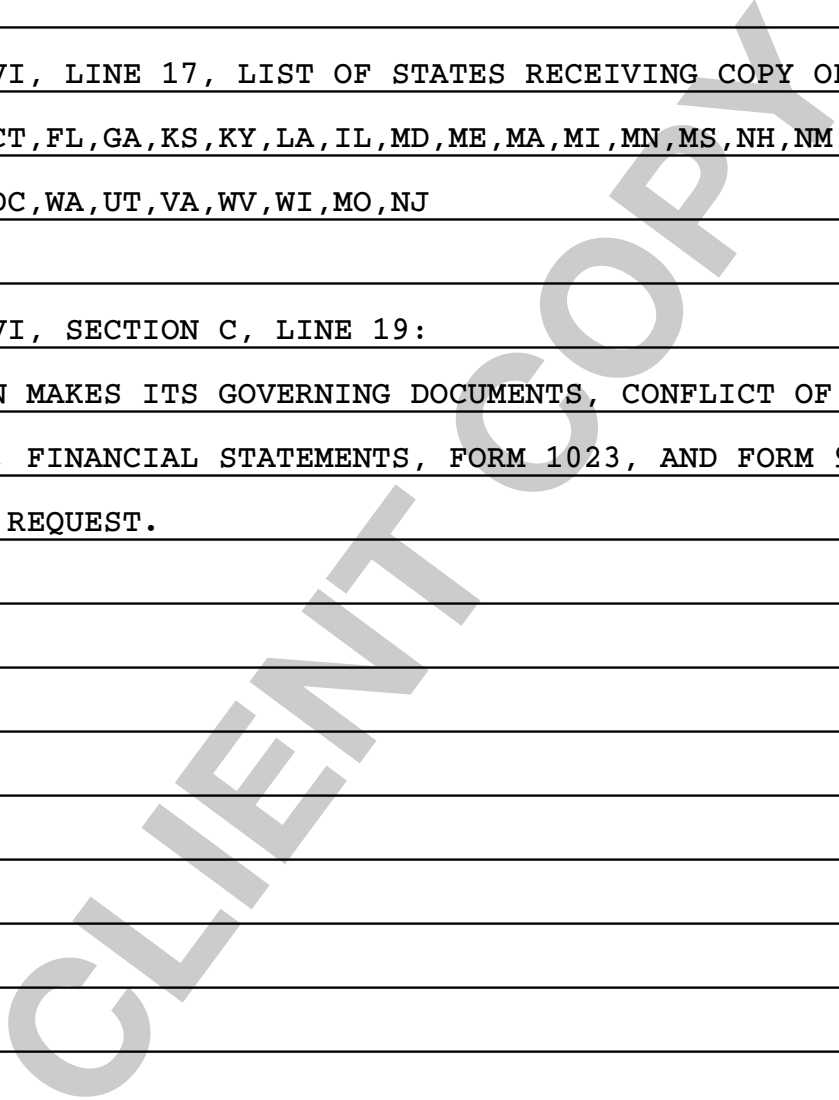
